Who: You have been invited to exhibit several paintings at the Marshfield Christian Church as part of the Ninth Annual Marshfield Cherry Blossom Festival on **Thursday and Friday, April 24 and 25, 2014**. This exhibit is in conjunction with a series of programs being held at the Church. Exhibit cards will be pre-printed by exhibit organizer from information you provide. (See below) Artists can have business cards available on a nearby table.

Eligible Work: will be two-dimensional, of any medium or combination of media. We request ORIGINAL art. Works must be attractively matted and/or framed and equipped with hook eyes and wire. Wrap-around canvases are acceptable if the edges are painted, and nails or staples do not show. Works can be no larger than 30 inches, and must otherwise be of a scale and weight easily handled and installed by the exhibit volunteers. However, this is a family festival, so **no nudes** will be accepted.

Receipt of Entries: We request that works be hand-delivered to the Church at **1061 St. Hwy A** on **Wednesday, April 24 between 5:30 and 7 PM**. (If you cannot be there at that time, please call me to make other arrangements.) Please bring standing easels if you have them, or let me know how many easels you will need me to provide. I will also have standing wire racks available. There is no entry fee. There are no prizes.

Pick up of Entries: Art may be picked up by the artist on **Friday, April 25 between 5 PM and 6:30 PM**. (Contact me ahead of time if you cannot be there at that time. Then I can bring them to my home for you to pick up later.)

Sales: Art on exhibit with the Cherry Blossom Festival can have NFS (not for sale), or can have a sale price on the exhibit card, along with your name and phone number. (The artist is responsible to pay the appropriate sales taxes.) We ask that no piece be removed until the end of **Friday's** program. Your buyer and you can complete the sale Friday at pick up time, 5 PM – 6:30 PM. The festival will **NOT** take a % of your sale, but would accept a donation.

Entry Form: Artists please fill out entry form (or phone me) with information for each piece being exhibited, so that exhibit cards can be prepared. Artists will also **attach identification tags** (or reasonable facsimile) to the back upper left corner of **each piece** being exhibited. Entry and identification tags will provide the following:
